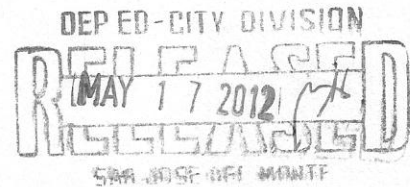

**DIVISION SEMINAR ON PRE-RETIREMENT INNOVATIONS AND OPTIONS FOR RESULTS
(PRIOR)**

1. The City Schools Division, city of San Jose del Monte, in its strong desire to adopt the Pre-retirement Program for Government Officials/ Employees as articulated in Civil Service Commission (CSC) Memorandum Circular (MC) No. 23 s. 1993, will conduct a Division Seminar on Pre-Retirement Innovations and Options for Results (PRIOR) on May 29-30, 2012 at 7:30am at Division Library Hub, City of San Jose del Monte, Bulacan.
2. The objective of this training is to equip the prospective retirees of DepEd-City of San Jose del Monte with additional knowledge to enhance their capabilities in activities that can be useful to them after their services from the government have been terminated and to provide them continuing opportunities for advancement by helping them discover innovations and options that will sustain them physically, psychologically, socially and financially in their retirement time.
3. Participants to this seminar are teaching and non-teaching personnel who plan to retire or are due to retire whether compulsory or optional within the next three (3) years. Enclosed is the list of compulsory retirees. Optional retirees (60 years old and above) need to confirm their attendance not later than May 25, 2012 for the food and certification of attendance.
4. Resource persons shall come from DepEd – City Schools Division, City Health and Legal Offices, Philippine Health Insurance Corporation (PHILHEALTH), PAG-IBIG Fund, Government Service and Insurance System (GSIS), Technical Education and Skills Development Authority (TESDA), Department of Trade and Industry (DTI) and the private sector. Attached is the program of activities.
5. Expenses to be incurred shall be charged against INSET Fund.
6. Immediate and wide dissemination of this information is enjoined.
