## Title: **International Seminar-Workshop on Mother Tongue-Based Multilingual Education in the Philippine Context**

Theme: ***One Voice, Many Languages: Teaching and Learning in the Mother Tongue***

### Objectives:

1. To inform participants of the latest studies on the implementation of DepEd's MTBMLE policy in the Philippines and compare these with UNESCO studies on other countries implementing the same;
2. To demonstrate the value of teaching in the mother tongue and how this can maximize learning in all subject areas; and,
3. To produce materials for mother tongue classes informed by sound frameworks of translation and language education.

#### **Session 1**

***Mother Tongue Education in the Philippine Context: Issues and Best Practices***

Only on its fourth year of implementation, the DepEd's MTBMLE has had its gains and setbacks in the various schools where it is implemented. Challenges to implementation include the highly diverse composition of our student populations especially in urban areas throughout the country where the classes are multiethnic and multilingual, lack of materials for some Philippine languages, and the mismatch between the language of teachers and students. However, there are also model schools which have implemented the program and may well be models of "best practices". This session aims to present a comparative view of the implementation of mother tongue education in the Philippines and in other countries as documented by UNESCO to encourage and establish the value of its implementation in the early years of education.

#### **Session 2**

***Teaching Young Learners their Mother Tongue: Strengthening Culture, Building Identities***

UNESCO reports over the last 40 years affirm the numerous advantages of strengthening the mother tongue and learning using the mother tongue. Four years into its implementation, the Philippine MTBMLE has met its share of opposition from stakeholders in all fronts, including teachers who are hesitant to teach the mother tongue much less use it as a medium of instruction and parents who are skeptic about the value of a language that they feel does not carry advantages nor prestige. The objective of this session is to clearly lay out before the participants the many benefits / advantages of teaching the mother tongue and using it as medium of instruction.

**Session 3**

**Materials Production Part 1: Frameworks of Translation**

The two implementing guidelines for the MTBMLE issued by the DepEd clearly identifies 19 languages to be used taught as Mother Tongue. In reality, the Philippines has around 187 languages and that classes in urban centers throughout the archipelago are multilingual and multiethnic in composition. The Cordillera is an example of a region which has many languages but no materials for any of these languages has been produced. There is thus this pressing need to produce more materials for languages that are yet to be recognized by DepEd. Teachers are usually burdened with this task. The objective of this session is to equip teachers with basic frameworks of translation to enable them with skills of producing materials for their own classes, teachers being in the best position to identify and address the needs of their own students.

**Materials Production Part 2: Interfacing Language and Literature**

As clearly laid out by the DepEd, the MTBMLE implementation is two-fold; to be used as medium of instruction and to be taught as a subject. In order to fully attain the objectives of the program, namely; (1.) language development which establishes a strong education for success in school and for lifelong learning; (2.) cognitive development which focuses on Higher Order Thinking Skills (HOTS); (3.) academic development which prepares the learner to acquire mastery of competencies in each of the learning areas; and (4.) socio-cultural awareness which enhances the pride of the learner's heritage language and culture (DepEd Order No. 16 s. 2012), materials need to integrate lessons MT classes. The objective of this session is to demonstrate strategies of integrating language and literature in MT materials design and production.
