- This training aims to articulate basic understanding of Continuous Improvement (CI), explain the CI methodology and its steps and demonstrate CI application at the school level with the guidance of a coach.
- 3. Participants are the CI Teams composed of five (5) Master Teachers/Teacher 3 in each school from Paradise Farms Community School, Minuyan Elementary School, Bagong Buhay G Elementary School, Bagong Buhay B Elementary School, Gumaok Elementary School, Benito Nieto Elementary School, Minuyan National High School, Towerville High School, San Jose Del Monte National Trade School, and Marangal National High School. The team leaders and members should not be changed nor replaced in the course of CI training and implementation.
- 4. Training and transportation expenses of resource speakers and staff shall be charged to Division Maintenance and Other Operating Expenses (MOOE) while transportation expenses of the School CI Team shall be charged to School MOOE/school canteen funds subject to the usual accounting and auditing rules and regulations.
