DIVISION ORIENTATION ON 2018 PRINCIPALS' TEST

- This Office announces the conduct of Division Orientation on 2018 Principals' Test for aspiring takers on September 24, 2018, 2:00 p.m. at Conference Hall, San Jose del Monte Central School, Poblacion, City of San Jose del Monte.
- The orientation aims to give applicants information on general guidelines on the conduct of 2018 Principals' Test and knowledge on how to accomplish the Principals' Test Online Application System (PTOAS).
- 3. Qualifications of the 2018 Principals' Test applicants are as follows:
 - a. One (1) year as Head Teacher; or
 - b. Two (2) years as Teacher In-Charge; or
 - c. Two (2) years as Master Teacher; or
 - d. Five (5) years as Teacher III or SPED Teacher; or
 - e. Five (5) years as Incumbent Public School Teacher who has five (5) years managerial
 and supervisory experience in a Deped recognized private institution or Commission on
 Higher education (CHED) recognized higher education institution; or
 - f. Education Program Specialist and Senior Education Program Specialist who will meet the minimum Qualification Standards for Principal I Position stipulated in DepEd Order No. 39, s. 2007
- Applicants must meet any one of the experience requirements for the entire career.
 Aggregated sum of the position experience requirement is not allowed.
- Those who failed to pass the 2015, 2016, 2017 Principals' Test shall be allowed to take the 2018 Principals' Test.

- 6. Documentary requirements for each applicant:
 - Official DepEd email account may be requested for activation/ creation from the Division ITO;
 - Approved Individual Performance Commitment and Rating Form (IPCRF), with a rating
 of at least Very Satisfactory (VS) in the last two (2) consecutive periods, duly certified
 true and correct by the authorized SDO personnel;
 - Teacher In-Charge (TIC) and Head Teacher (HT) acting as school heads are required to secure Office Performance Commitment and Rating Forms (OPCRF), approved by the approving authority;
 - d. Service Record duly signed by the SDO Administrative Officer IV (HRMO);
 - e. If applicable:
 - e1. Designation Order as TIC or OIC signed by the Schools Division Superintendent;
 - e2. Certification of managerial and supervisory experience from DepEd-recognized private institution or CHED-recognized higher institution.
