FOR SCHOOL YEAR 2017-2018**

1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), with the assistance of schools divisions, public and private schools personnel, will administer the Early Language Literacy and Numeracy Assessment (ELLNA), and National Achievement Test for Grade 6 (NATG6) and Grade 10 (NATG10) for School Year 2017-2018 on the following dates:

| Date | Test | Grade Level of Test Takers |
|--------------------|--------|---|
| September 25, 2018 | NATG10 | Grade 11 learners from sampled public and private schools |
| September 27, 2018 | NATG6 | Grade 7 learners from sampled public and private schools |
| October 10, 2018 | ELLNA | Grade 4 learners from sampled public schools |

2. The administration of these tests is pursuant to DepEd Order (DO) No. 25, s. 2018 entitled School Calendar for School Year 2018-2019, and DO 55, s. 2016 entitled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program.

3. The authorized forwarder shall deliver the test materials to schools division offices (SDOs) outside the National Capital Region two weeks before the test administration. The same forwarder shall retrieve the test materials one week after the test administration.

4. The list of sampled schools will be sent through email to the SDOs through the Division Testing Coordinators (DTCs).
