The Department of Education (DepED) City Division of San Jose del Monte, through the 2020 Basic Educational Facilities (BEFF), intends to apply the sum of **Philippine Pesos Twenty Seven Million Twenty Eight Thousand Four Hundred Seventy and 44/100 (PhP 27,028,470.44)**, being the Approved Budget for the Contract (ABC), to eligible payments under the contract for the **CY 2020 BEFF – Repair and Rehabilitation of School Buildings**. Bids received that exceed the ABC per lot shall be rejected at bid opening.

The DepED City Division of San Jose del Monte, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Prospective bidders must have completed an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, and must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (2016 Revised IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy-five percent (75%) interests or outstanding capital stocks belonging to citizens of the Philippines.

A complete set of Bidding Documents may be inspected or purchased at the DepED City Division of San Jose del Monte BAC Secretariat, located at Supply and Property Unit Office upon accomplishing a bidder's information sheet and payment in cash by interested bidders in the amount of **Php. 7,000.00 for Lot 1, Php. 6,000.00 for Lot 2, Php. 8,000.00 for Lot 3 and Php. 7,000.00 for Lot 4** to the DepED Division Office Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).
