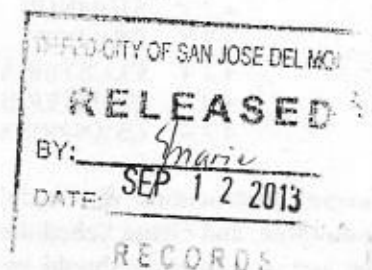

2013 CITY DIVISION ATHLETIC MEET

1. **Date and Place** – The Elementary and Secondary Levels, Public and Private Schools in the City Schools Division will hold the 2013 City Division Athletic Meet on October 21-23, 2013 to be hosted by Sapang Palay National High School.
2. **Sponsorship and Management** – The event will be sponsored by the DepEd, Division of City Schools, City of San Jose del Monte, in coordination with the Sangguniang Panglunsod, City Youth and Sports Development Office (CYSDO), all public elementary and secondary schools, and CSANPRISA. It is managed by the Board of Directors, the Division Staff and working committees.

7. **Screening of Athletes** – The following required forms/documents should be screened by the Division Screening Committee at the Division Office on October 14-18, 2013.

- 6.8 6 pcs. Passport Size identical pictures (with name tag) [surname, first name, middle initial, and grade/year level] with white background.

8. **Tournament Format** – The tournament format is double elimination for team events and single elimination (individuals), round robin (doubles/team) for racket games.
9. **Determination of Champion** - Champion to this 1st CSJDM DepED Teachers' & Employees' Athletic Tournament will be determined by point system found in Inclosure C.
10. **Duties and Responsibilities** – Heads of delegation, school heads, coaches, and chaperons are responsible for the age eligibility of athletes, discipline, and the observance of all rules and regulations governing the athletic meet.
11. **Subsistence and Transportation** – Each participating delegation should take charge of the subsistence of their own contingent including game officials coming from each cluster/delegation.
12. **Attendance** – Teachers who are not assigned / designated coaches, chaperons, officials, working committee, and meet officials are expected to hold regular classes as usual.
13. **Solidarity Meeting** – Meeting of tournament managers, officiating officials, coaches, and chaperons will be held on October 18, 2013, 1:00 p.m. at Sarmiento Gym, Sapang Palay National High School.
14. Wide dissemination of this Memorandum is highly desired.

RULES AND GUIDELINES ON SCREENING AND ACCREDITATION OF ATHLETES, COACHES AND CHAPERONS

1. Participants

- a. Participants are elementary and secondary pupil/student athletes from the public and private schools who have participated in the lower meets.

2. Eligibility of Athletes

- a. Must be a Filipino citizen.
- b. Must be enrolled in a recognized school at the beginning of the current school year.
- c. Must have attended/finished the curriculum year.
- d. Should have participated in the preliminary meets (District/Cluster).
- e. For Elementary athletes, he/she should have been born in 2001 or after, and for Secondary athletes in 1996 or after. Thereafter, add one (1) year to the cut-off date for the succeeding year.
- f. Pupil/student athletes who transferred from one region are allowed to participate, provided their transfer was done at the beginning of the school year. Transferee from one division to another within the region is allowed to participate provided they have participated in the lower meets.
- g. As a general rule, elementary athletes shall play in the elementary division, and secondary athletes shall play in the secondary division. However, elementary athletes who have been declared overage in the elementary level may be allowed to play in the secondary level.

3. Disqualification

- a. Over-aged athletes.
- b. Elementary athletes with 3rd molar tooth.
- c. Athlete with failing grades in more than two (2) core subjects in the 2nd grading period.
- d. Athlete who are member of the National Team, national training pool and development pool receiving monthly stipend/allowances from the PSC.
- e. Athlete/Coach/Chaperon who failed to submit the required documents.
- f. Banned during the previous Division, Regional, and Palarong Pambansa.

4. Required documents to be submitted during screening

- a. List of athletes by event indicating the gender, date of birth, school and school type (public/private), LRN/Student Number, school address name of coach duly signed by the coach and the head of the delegation on hard copy. (3 copies, 1 for the Unit Chairman, 1 for the Tournament Manager, and 1 for the Division PESS Supervisor)
- b. Athletes' Record signed by the athlete, coach, and Division PESS Supervisor
- c. Original and photocopy of birth certificate issued by the National Statistics Office (NSO) / Local Civil Registrar. Late registration may be accepted provided; it was issued one (1) year prior to current Palarong Pambansa.
 - i. In the case of foreign born Filipino athlete, in lieu of NSO birth certificate, the original birth certificate issued by the country of his/her birth and a valid Philippine passport or a document issued by the Bureau of Immigration/Department of Foreign Affairs, showing his/her nationality as a Filipino.
- d. Form 137 (with LRN – for Public schools athletes and Student Number – in case of private schools athletes), certified true copy from original or computer printed, duly prepared and signed by the teacher-adviser, with fresh signatures of the registrar/principal/school heads, and by the Division PESS Supervisor.
 - i. In case the second grading period does not indicate at the Form 137 of athlete, attached photocopy of Form 138 (Report Card).
 - ii. In cases of athletes who are enrolled under the Alternative Delivery Mode (Home Study Program/Open High School Program), a copy of the numerical/descriptive

rating equivalent to the second grading period of the regular classes should be submitted.

- e. Certification of Enrolment duly signed by the adviser, school registrar or the school head.
- f. Parent or guardian's consent verified by the teacher-adviser/principal/registrar.
- g. Medical Certificate signed by a physician stating that the athlete is physically fit and within the age limit required with a validity of three (3) months from the date of issue. (The complete name of signing physician shall clearly appear on this document, with the license number and date of examination.)
- h. Dental Certificate with universal entry, duly signed by a dentist over his/her clearly printed name and licence number, and with the date of examination which should not be more than six (6) months prior to the date of the opening of the current Palarong Pambansa.
- i. School Identification Card (photocopy)
- j. Six (6) pcs. of 1½ x 1½ identical pictures with name tag (surname, first name, and middle initial) and grade/year level of the athlete. [athletes' record, medical, dental, form 137, gallery, original BC]
- k. Affidavit of the Coach (Sworn Statement for Public School/Affidavit for Private School) attesting the authenticity, validity and correctness of the entries on the above-mentioned documents submitted.

5. Eligibility of Coaches and Chaperons

5.1 Coaches and chaperons must be school or DepEd personnel. Coaches and chaperons from private schools must have been in the service for at least six (6) months.

5.2 Documents to be submitted:

- 5.2.1. Certificate of Employment
- 5.2.2 Form 212 (PDS)
- 5.2.3 Four (4) pcs. of 1½ x 1½ identical pictures with name tag [certificate of employment, PDS, Medical, Gallery]
- 5.2.4 Medical certificate
- 5.2.5 Duly sworn statement (for public schools) / Affidavit duly notarized (for private schools)

6. Screening of Athletes

- a. The Division Screening and Accreditation Committee (DSAC) shall:
 - i. Receive and examine all athletes' documents at least one (1) week before the start of the Division Athletic Meet.
- b. Special Cases
 - i. In case where there is a discrepancy on the entry in the NSO and Form 137, the following documents shall be presented:
 - 1. In cases where there is discrepancy on the entry of name in the NSO and Form 137, the entry in the NSO shall prevail.
 - 2. Joint affidavit of two (2) disinterested persons certifying on the true date of birth.
 - 3. Local Civil Registry (LCR) issued Birth Certificate.
 - ii. In cases where the first or last name is not found at the top portion of the NSO but at the box below, the following shall be submitted:
 - 1. Live Birth Certificate issued by the LCR
 - 2. Copy of the application / petition duly received by the LCR (supplemental reports to the LCR/Court)
 - 3. Affidavit of parents
 - 4. Affidavit of two (2) disinterested persons
 - iii. When an illegitimate athlete uses the surname of his/her father, he/she shall submit an acknowledgement by the father, and an annotation on the NSO (subsequent marriage of the parents)
 - iv. When the gender cannot be categorically determined, an affidavit of two (2) disinterested person shall be submitted.
 - v. Unreadable entries shall be supported by the original live birth certificate from the LCR.

7. Replacement of Athletes prior to the issuance of the Master list of Accredited Athletes

- a. Replacement of the athletes may be allowed only before the final deliberation of athletes upon the written request signed by the coach and the head of the unit delegation, on the following grounds:
 - i. Medical/health reasons
 - ii. Original athlete is not screened
 - iii. None or incomplete set of required document on the date set by the DSAC.
 - iv. Original athlete is not eligible to play due to over-aged, impersonation, etc.

8. Protest on Eligibility

- a. Protest shall be in writing and duly signed by the coach and the head of the school or his/her official representative and shall be filed **before the start of the second game** of the concerned team with the chair of the DSAC. Protest filed by other person shall be automatically dismissed without prejudice of refiling the same upon compliance of the above-mentioned requirement.

The **Division Screening Accreditation Committee** may **MOTU PROPIO** conduct investigation if there is an obvious truth or merits of the allegation questioning the eligibility of the athlete.

- b. Protest shall be accompanied by evidences to support thereof.
- c. The protest shall be acted immediately by the DSAC upon receipt thereof. Decision of the DSAC shall be appealable only to the Schools Division Superintendent.
- d. Athletes who have been disqualified on the grounds provided in these rules may appeal the decision of the DSAC. However, the appellant cannot play pending the resolution of his appeal.
- e. The protestant shall have the burden of proving his allegations and shall provide necessary evidence (documentary/ testimonials), otherwise, the protest will be dismissed "MOTU PROPIO".
- f. The DSAC may also conduct investigation on complaint/s of misinterpretation, impersonation, and violations of similar nature, for purposes of determining the eligibility of the athlete without prejudice of filing administrative and criminal action.

9. Sanctions

- a. Any violation of the rules on eligibility is punishable by lifetime ban from participating in school sports competition without prejudice to the filing of appropriate administrative and criminal charges against erring officials and athletes.
- b. When a violation on eligibility rules is proven in team competitions, the games in which the individual has taken part shall be declared forfeited in favor of the opposing team. The individual performance, in case of individual event shall be nullified.

10. Ground Rules

- a. Rule 9.1 shall be strictly enforced against erring coach; however, one (1) year suspension to play in any event shall be enforced against erring athletes.
- b. Athletes included in the official list of qualified athletes in higher level athletic meet, but refuse to play without valid reason will be penalized by one (1) year suspension to play in any event the following school year. Likewise, the same sanction will be enforced to the school, if the school failed/did not allow the athlete to participate in the said athletic meet.
- c. A comprehensive preliminary screening of athletes' documents shall be the main responsibility of the Head of Delegation. No athlete shall be recommended by the Principal without having been validated by the District/School Committee on sports.
- d. Head of Delegations and Principals will be held liable to any discrepancies on their athletes' eligibility.
