THIRD NATIONAL CONFERENCE OF CHILDREN'S LIBRARIANS

In celebration of the National Children's Month in October, the National Library of the Philippines (NLP) will hold its Third National Conference of Children's Librarians with the theme Connecting and Linking of Information through Transformed Children's Libraries to the Era of Digital Information from October 13 to 15, 2014 at the Tagaytay International Convention Center, General Aguinaldo Highway, Tagaytay City, Cavite.

The Conference aims to:

- 1. help the participants build a collection of digital online resources;
- 2. introduce a system for mapping accessible resources; and
- 3. provide access to high-quality children's services through utilization of modern technology.

The participants will be given the opportunity to own an account that will provide access to free electronic resources from 42 eLibrary USA databases, sponsored by the Thomas Jefferson Information Center (TJIC) Public Affairs Section, U.S. Embassy.

The target participants are teachers, librarians, and library hub coordinators/librarians from both public and private schools nationwide.
