

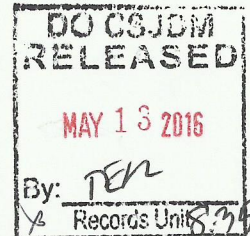


**ORIENTATION ON DENGUE PREVENTION AND CONTROL PROGRAM
