

Division Memorandum

To : Public School District Supervisors
Public Secondary and Elementary School Heads
CSS Master Trainers and TWGs
All others concerned

1. There will be a National Simulation Earthquake Drill (NSED) on Wednesday, June 22, 2016 at 9:00 a.m. In relation to this, all public schools are hereby directed to simultaneously join the said activity by activating the Incident Command System for *Standardized School Disaster Drill* per DepEd Order No. 83, s. 2011 "**Disaster Preparedness Measures for Schools**" and DepEd Order no. 300, s. 2006 "**Quarterly Conduct of Earthquake Drill**".
2. SPG/SSG (Student-Led School Watch Team) and their adviser will assess the disaster drill based on the Comprehensive School Safety - Drill Evaluation Guide/Checklist (Enclosure no. 1).
3. All PSDSes, CSS Master Trainers and TWGs shall convene at San Isidro Elementary School with Save the Children Staff, PDRRMO, CDRRMO and OCD-R3 for benchmarking.
4. For wide dissemination and strict compliance.
