2017 HISTORY MONTH CELEBRATION

1. Pursuant to Presidential Proclamation No. 339 s, 2012, "Declaring the Month of August of Every Year as History Month", this Office enjoins all schools to observe this national commemoration through appropriate and meaningful activities.
2. The Commemoration Activities should promote deeper understanding of National and Local History (Kasaysayang Lokal) and pursuit of nationalism and national consciousness..
3. Classroom-based activities shall be conducted from August 1-31, 2017 consisting of, but not limited to, the following:
 - a. School and Barangay History Fora/ Symposia
 - b. History Telling /Film viewing
 - c. Local History Museum/Gallery of Heroes
 - d. History Bulletin Board
 - e. History Theater (shadow, doll or actual performance)
 - f. Spoken poetry focusing on heroism and helping other people
 - g. Advocacy Wall- Panawagan sa Kapayapaan at Comprehensive Socio-Economic Reform
 - h. Current Social Issues of San Jose del Monte City.
4. Significant teachings in Philippine History shall also be discussed such as:
 - a. The Kartilya ng mga Anak ng Bayan by Emilio Jacinto
 - b. Ang Tunay na Dekalogo by Apolinario Mabini
 - c. Kodigo ng Kagitingan at Kagandahang Asal by Manuel Quezon
 - d. Pag-ibig sa Tinubuang Lupa ni Gat Andres Bonifacio
5. Report of conduct of activities in photo or video shall be submitted online through the facebook page of SANGKAP (Samahan ng mga Guro ng Kasaysayan at Araling Panlipunan)
6. Certificate of Recognition shall be given to schools who significantly conducted the Activities for the whole month.
7. **Conduct of beauty pageant/ Mr. and Ms./income generating film viewing and the likes are strictly prohibited.**
8. Expenses relative thereto shall be charged against Student Development Fund(D.O 8 s.2007) subject to usual accounting and auditing procedures while the Division Office expenses shall be charged against duly appropriated Division MOOE.
