
- Pursuant to DepEd Unnumbered Memorandum s. 2016, this Division announces the conduct of Training on Continuous Improvement for Master Trainers (MT) and Master Coaches (MC) on June 19-20, 2017, venue to be announced later.
- 2. This training aims to:
 - a. deepen participants' understanding of the 10 steps of CI;
 - b. highlight and emphasize critical points under each CI step;
 - identify the strengths and weaknesses of school-based CI projects done by some model schools in the Division;


