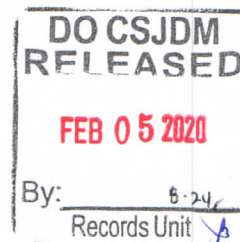



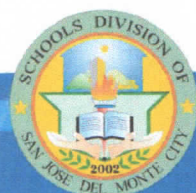


**2020 BRIGADA ESKWELA JINGLE MAKING CONTEST**

**MECHANICS FOR THE 2020 BRIGADA ESKWELA JINGLE MAKING CONTEST**

**1. COMPOSITION**

- It must be in Filipino language.
- It must be relevant to the theme.
- The time duration must not be more than two (2) minutes.
- It must be an original composition made by the learners and may be through the guidance of a music teacher/coach.
- Any musical instrument may be used as accompaniment.
- The composition shall be performed by the learner/s of the participating school.

**2. PARTICIPANTS**

- The contest is open to all learners of public elementary and secondary schools.
- Composer can be either an individual or a group of learners.
- For the Regional Level, 1 entry per division may qualify.

**3. ENTRY FORMAT AND REQUIREMENTS**

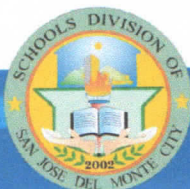
- Each school is allowed to send one official entry.
- Entries shall be submitted in an MP3 format with the title of the Jingle entry as the file name.
- Entries must be sent in a USB flash disk or DVD/Optical Disc with the following requirements:
  - a. Accomplished Entry Form (Enclosure No. 2)
  - b. Narrative report on the concept of the jingle.
  - c. Lyrics of the jingle
  - d. Profile of composers and the music teacher/coach (which can be found in the Entry Form)
  - e. The deadline for submission of entries shall be on or before February 17, 2020.
  - f. The decision of the judges is final and irrevocable.
  - g. Winners will be announced through a Division Memorandum.

**4. CRITERIA FOR JUDGING**

Originality -	40%
Musicality- (Melody, Arrangement, Instrument/Accompaniment, Tone	40%
Relevance and Appropriateness to the BE Program and the theme	20%
<b>TOTAL-</b>	<b>100%</b>

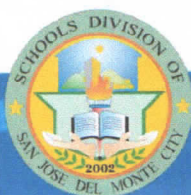
