2. As per DepEd Memorandum No. 127, s. 2014, the administration of National Achievement Test (NAT) and Language Assessment for Primary Grades (LAPG) for SY 2014-2015 shall be on the following dates:

- March 5, 2015 – NAT Fourth Yr HS (All Public Schools & Private Schools with permit to operate from the DepEd)
- March 11, 2015 – LAPG Grade 3 (Public Schools only)
- March 12, 2015 – NAT Grade 6 (All Public Schools & Private Schools with permit to operate from the DepEd)

- Objectives of LAPG and NAT;
- Proper conduct/administration of the test;
- Standard procedure in test administration
- Security of test materials, delivery, retrieval scheme;
